



## **Declaration Of Honour On Good Standing, Conflict Of Interest And Corruption**

### **A. Good Standing**

Medical Support Solutions Limited:

- v) Has not been the subject of a judgement which has the force of res judicata for fraud, corruption, involvement in a criminal organisation, money laundering or any other illegal activity;
- vi) Declares that the natural persons with power of representation, decision-making or control over the above-mentioned legal entity are not in the situations referred to in i) and ii) above;

### **B. Conflict of Interest**

Medical Support Solutions Limited, its directors, management, employees, workers and agents:

- i) Will declare and disallow any conflict of interest in connection with any of its business activities; a conflict of interest could arise in particular as a result of economic interests, political or national affinity, family, emotional life or any other shared interest;
- ii) Will inform the relevant authority, without delay, of any situation considered a conflict of interest or which could give rise to a conflict of interest;



### **C. Corruption**

Medical Support Solutions Limited, its directors, management, employees, workers and agents:

- i) Has not granted and will not grant,
- ii) Has not sought and will not seek,
- iii) Has not attempted and will not attempt to obtain,
- iv) And has not accepted and will not accept,

Any advantage, financial or in kind, to or from any party whatsoever, where such advantage constitutes an illegal practice or involves corruption, either directly or indirectly, inasmuch as it is an incentive or reward relating to award of the contract;

- v) Will inform any relevant authority, without delay, of any situation which may be considered or cause to be considered a corrupt act or action.

### **E. Acknowledgement**

Acknowledges that Medical Support Solutions Limited may be subject to administrative and financial penalties<sup>1</sup> if any of the declarations or information provided prove to be false.

### **F. Binding Nature of the declaration**

This declaration is binding on all directors, management, workers and employees of Medical Support Solutions Limited. Sections B and C form part of the standard employment contract of all Medical Support Solutions employees.
